## GUIDANCE NOTES FOR COMPLETION OF THE CLAIM FORM

1) Section 1 of the claim form lists the personal details that will enable your tax office to deal with your claim. It is very important that you put your National Insurance Number on the form. It looks something like: AB 12 34 56 C. You can find your National Insurance Number on Form P60, (the form your employer should give you in April/May each year which tells you your total income for the year). It is also on letters you may have received from HM Revenue & Customs and your payslip.

2) Section 2 of the claim form lists the information that HM Revenue & Customs will need to process your claim. Firstly you need to confirm that you are, or have been at some time since 6 April 2004, a member of one of the named sectors of the UNISON Health Care Service Group by placing a tick in the appropriate box(es). A broad description of the membership of each of the sectors is shown overleaf. **If you are a member of UNISON by virtue of your membership of the British Association of Occupational Therapists you should not complete the claim form because you do not pay a subscription direct to UNISON.**

3) Next you need to enter details of the UNISON subscriptions paid by you in the years during any part of which you were a member of any of the named sectors. If you were not a member of a named sector for the entire year you should only claim that proportion of your

## QUALIFYING SECTORS

### Nursing sector

The Nursing sector covers the whole nursing family including nurses, midwives, health visitors and healthcare assistants working in the community, schools, mental health, dentistry, GP practices, learning disabilities, maternity care, hospitals and the prison service.

### Ambulance sector

The Ambulance sector covers all grades of ambulance staff and paramedics serving in every ambulance service in the United Kingdom.

### Voluntary Sector

The Voluntary sector covers members who work for a non-NHS voluntary sector organisation (such as a charity, community group or social enterprise) providing services such as home, residential or day care, or rehabilitation and social work.

### Senior and General Managers' sector

The Senior and General Managers' sector covers heads

of services, directors, assistant directors, professional managers, organisers, co-ordinators and team leaders within the NHS and its support services.

### Professional and Technical 'A' sector

The Professional and Technical 'A' sector covers members who, prior to Agenda for Change, came under the PTA section of the Whitley Council pay structure, including members working in areas such as art, music and drama therapy, occupational therapy, speech and language therapy, physiotherapy, psychology, orthoptics, dietetics, chiropody and radiography.

### Professional and Technical 'B' sector

The Professional and Technical 'B' sector comprises professional and technical staff covered by the old PTB Whitley Council working as operating department practitioners and assistants and those working in anaesthetics,

chaplains, counselling, dialysis, estates management, optometry, phlebotomy, podiatry, prosthetics and orthotics, sexual health, healthcare scientists including clinical scientists who work in biochemistry, gastroenterology, haematology, haemostasis and thrombosis, microbiology, immunogenetics and histocompatibility, immunology molecular genetics, medical physics, respiratory physiology and clinical engineering, cytoscreeners, laboratory support staff and perfusionists, technicians/technologists who work in anatomical pathology, audiology, dentistry, physiological measurements and cardiology, gastroenterology, hearing, respiratory, medical physics, engineering, renal, physiology, neurophysiology, and medical illustrators and photography, dental auxiliaries, hygienists and therapists, pharmacists, pharmacy technicians and pharmacy assistants.
