## **AFFILIATIONS POLICY**

Criteria for recommending affiliation: to be confined to organisations which:

- (i) affect jobs and relate to members terms and conditions
- (ii) give UNISON influence over important policy areas, including joint work with other unions, and
- (iii) provide essential information and assistance to carry out core functions.

Further, PDCC (on behalf of the NEC) has agreed that organisations must fulfil the following requirements:

- (a) have remit and objectives in line with UNISON's Aims, Objectives and priorities.
- (b) Their constitutions and Annual General Meetings should be open and democratic;
- (c) They should have elected executives;
- (d) They should be financially accountable and open to scrutiny by independent auditors.

In relation to equalities – organisations should

- (1) share UNISON's aims and values
- (2) support the principles of self-organisation
- (3) be committed to black leadership of anti-racist organisations (National

Black Members Conference)

## AFFILIATING TO OUTSIDE ORGANISATIONS

In 2002 the NEC adopted a set of criteria to be used when considering affiliations or donations to outside organisations and bodies. It adopted the following wording:

"We have a fiduciary duty, entrusted to the Trustees of the union, to ensure that our member's money is spent correctly and that organisations we entrust funds to have aims and objectives in line with our own and are financially open and accountable.

To that end the organisation must

- Produce a set of fully audited accounts and a bank account
- Have a permanent address and not a PO box or forwarding address
- Provide full details of its management/governing body
- Prove it has a democratically elected governing body
- Provide copies of recent agendas and minutes
- Provide details of how UNISON's affiliation is to be used."
